Criminal Justice Grants Program Plan Year 2021 Timeline (Updated Aug. 1, 2019)

Office of the Governor, Criminal Justice Division Grants Application Process

Timeline will be updated as important dates are identified

- September 3, 2019 – Send PY 2021 CAPCOG Regional Criminal Justice Needs Survey out to stakeholders
- September 22, 2019 – Response period ends for PY 2021 CAPCOG Regional Criminal Justice Regional Needs Survey
- September 26, 2019 - CJAC Meeting to kick off new grant year, and update Policy Statement
- October 8, 2019 Morning – Stakeholder Planning Meeting #1 – CAPCOG Pecan Room
- October 8, 2019 Afternoon – Stakeholder Planning Meeting #2 – CAPCOG Pecan Room
- October 10, 2019 Morning – Stakeholder Planning Meeting #3 – CAPCOG Pecan Room
- October 10, 2019 Afternoon – Stakeholder Planning Meeting #4 – CAPCOG Pecan Room
- November 2019 Date TBD - CJAC Meeting to update priorities and give input on the PY 2021 CAPCOG Regional Strategic Criminal Justice Plan
- December 11, 2019 – CAPCOG Executive Committee approves new regional plan and priorities
- December 2019 – PY 2020 RFAs released by Office of the Governor for Plan Year 2020
- **January 2020 – Mandatory grant writing workshops. Grant applicants applying to provide services in the CAPCOG region must attend one to be eligible.**
- **February 2020 – Criminal justice grant applications due to CJD via eGrants**
- Mid-March 2020 – 14 days after application period closes CJD forwards: General Victim Assistance – Direct Services; Violence Against Women Criminal Justice and Training Program; Juvenile Justice Grant Program; and Justice Assistance Grant Program applications to COGs
- March 2020 – CJAC Meeting to go over scoring process and discuss applications prior to application review meetings
- **April 2020 – Three-days of CJAC application review meetings at CAPCOG (3rd day of meetings will be dependent on the number of applications)**
- April 8, 2020 – Final Priority List presented to CAPCOG Executive Committee for Approval
- May 9, 2020 – Regional project prioritization list from CAPCOG due to CJD
- August 31, 2020 – FY2020 performance period ends
