- October 7, 2021 – Response period ends for PY 2023 CAPCOG Regional Criminal Justice Regional Needs Survey
- October 19, 2021, 1:30-4:30 p.m., – Stakeholder Planning Meeting #1, CAPCOG Lantana
- October 20, 2021, 9-Noon., – Stakeholder Planning Meeting #2, Virtual
- November 9, 2021, 10 a.m. to 2 p.m., – CJAC Meeting to update Score Sheet, approve priorities and Policy Statement, and give input on the PY 2022 CAPCOG Regional Strategic Criminal Justice Plan

- February 3, 2022 – Criminal justice grant applications due to CAPCOG for review
- February 10, 2022 – Criminal justice grant applications due to CJD via eGrants
- Early/Mid-March 2022 – CJD forwards: Criminal Justice Program, General Victim Assistance – Direct Services; Juvenile Justice and Truancy Prevention Grant Program; Residential and Community-Based Services for Victims of Commercial Sexual Exploitation of Children; and, Violence Against Women Criminal Justice and Training Program applications to COGs
- TBD March 2022 – CJAC Meeting to go over scoring process and discuss applications prior to application review meetings
- **March 23, 24, & 25, 2022 – Three-days of CJAC application scoring meetings at CAPCOG**
- **March 31, 2022 - (4<sup>th</sup> day of meetings will be dependent on the number of applications)**
- **March 31, 2022 – CJAC meeting to review prioritized lists of applications and make funding recommendations.**
- **April 13, 2022 – Final Priority List presented to CAPCOG Executive Committee for Approval**
- May 6, 2022 – Regional project prioritization list from CAPCOG due to CJD
- August 31, 2022 – FY2023 Plan Year period ends
