Mr. Morales asked the Board to consider approving the purchase of GeoComm Data Hosting, Data Hub and Spatial Interface (SI) services through AT&T. To provide true NENA i3 NG9-1-1 services through geospatial routing, GIS data must be uploaded by agencies via a secure webpage. The GeoComm Data Hosting service is an Amazon Web Services (AWS) purchased service, which allows the computing power and security of AWS without the in-house additional router and server equipment purchases and maintenance. This will be a multi-node service and customer faced platform.

Mr. Morales also shared that the total cost for all three services on a 5-year contract is \$1,325,073.75 or \$265,014.74 annually, and that funding is from the current budget and from the unassigned funds balance.

Mayor White asked for a motion to approve the purchase of GeoComm Data Hosting, Data Hub and Spatial Interface (SI) services through AT&T. Mayor Hughson made a motion to approve. Judge Haden seconded the motion. It passed unanimously.

AGENDA ITEM: 3. Consider Adopting a Resolution Setting the 9-1-1 Service Fee for FY2025

GENERAL DESCRIPTION OF ITEM:

In Texas, there are three components to the overall 9-1-1 fee:

- 9-1-1 Service Fee; charged to each local access line or equivalent and known as traditional landline service, currently \$.50 per month.
- 9-1-1 Wireless Fee; charged to each activated cell phone, currently \$.50 per month.
- 9-1-1 Prepaid Wireless Fee, currently two percent (2%) of the purchase price.

The 9-1-1 wireless fee and the 9-1-1 prepaid wireless fee are set at the state level. The 9-1-1 service fee is set by the state for the Councils of Government and by the boards of each Emergency Communications District or Municipal Emergency Communications District.

Texas Health and Safety Code Section 772.516 (e) requires the district board to set the 9-1-1 service fee each year as part of the annual budget. The 9-1-1 service fee pertains to the traditional landline and Voice over Internet Provider (VoIP) telephone services within the district and is charged to each residential line, business line and business trunk. The revenue generated from the 9-1-1 service fee is determined by the number of wireline or landline connections in the region. The \$.50 rate has been standard in the CAPCOG region since before the 9-1-1 District was established in 2013. Subsequently, as the number of wireless users has increased over the years the number of wireline users has diminished resulting in the 9-1-1 Wireless Fee increasing and the 9-1-1 Service Fee decreasing. Currently, the total number of wirelines in the CAPCOG region is 568,268 dropping from 665,819 in 2022, and 607,225 in 2023. To ensure adequate funding in the coming years as wireline users continue to decrease and population plateaus, an increase in the 9-1-1 service fee should be considered. The proposal for the FY 2025 budget to be approved by the Board at the July 2024 Board of Managers meeting would increase the 9-1-1 service fee rate from \$.50 to \$1.00 for Fiscal Year 2025 resulting in a revenue gain of \$284,134.00.

RESOLUTION

A RESOLUTION CLASSIFING RATES FOR THE 9-1-1 EMERGENCY SERVICE FEE ON SERVICE USERS FOR LOCAL EXCHANGE ACCESS LINES AND EQUIVALENT LOCAL EXCHANGE ACCESS LINES

WHEREAS, the Capital Area Emergency Communications District Board of Managers is authorized by Texas Health and Safety Code, Chapter 772 to impose a 9-1-1 emergency service fee on service users for local exchange access lines and equivalent local exchange access lines;

WHEREAS, in accordance with Texas Health and Safety Code, Section 771.063, the Capital Area Emergency Communications District is required to follow the definition of a local exchange access line and an equivalent local exchange access line as adopted by rule by the Commission on State Emergency Communications;

WHEREAS, in accordance with Texas Health and Safety Code Chapter 772.516(d), the rate of the fee may not exceed six percent of the monthly base rate charged a service user by the principal service supplier in the participating jurisdiction;

WHEREAS, in accordance with Texas Health and Safety Code Chapter 772.516(e), the board shall set the amount of the fee each year as part of the annual budget; and

WHEREAS, the schedule of fee rates and classifications recommended by District management for Fiscal Year 2025 complies with the six percent cap in Texas Health and Safety Code, Chapter 772.516(d).

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MANAGERS OF THE CAPITAL AREA EMERGENCY COMMUNICATIONS DISTRICT THAT: The 9-1-1 emergency service fee rates and classifications for Fiscal Year 2025 are hereby levied at the monthly rate of \$1.00 per line for residential lines, business lines and business trunks. The fees are applied to a maximum of 100 lines per customer bill, per location.

AGENDA ITEM: 4. Consider Amending FY 2024 Budget to Add Proposition 8 Funding

GENERAL DESCRIPTION OF ITEM:

This purpose of this item is to amend this year's budget to add the \$12,400,329.42 in funding that the Commission on State Emergency Communications (CSEC) allocated to the CAECD in March 2024 from the Proposition 8 funding that passed in November 2023. CAPCOG's share of the funding was based on population and a redistribution to ensure that all districts received at least \$373,492.32 in funding. The CAECD has already received half of the allocation, and we expect to receive the additional funding in the final quarter of FY 2024. Additional funds beyond the \$12,400,329.42 may be received as a result of interest accrual prior to disbursement from the state. Since this funding is not yet included in the FY 2024 budget and all of the funding is expected to be received in FY 2024, we are requesting a budget amendment to add this funding to the FY 2024 budget to offset expenditures tied to the CHE project, either in this year or subsequent ones.
