1. Welcome and Introductions

Donald Tracy, Chair, called meeting to order at 10:43 am and began the introduction of EDAC members.

2. Approval of February Minutes

Donald Tracy, Chair presented the motion to approved EDAC meeting minutes from 02/21/2025. Council Member, Frank Ortega, Vice Chair, was the first to approve the motion with Mayor Jane Hughson second to approve the motion. Motion carried unanimously by EDAC members.

3. Introducing Texas' 6th Spaceport: the Central Texas Spaceport Development Corporation

Scott Smith, Assistant Director of Economic Development for the City of Cedar Park, introduced the Central Texas Spaceport Development Corporation (SDC), a new nonprofit organization and the sixth designated spaceport in Texas. The SDC will focus on building infrastructure to support spacecraft, rocket, and satellite activity, while also advancing economic development, strategic partnerships and funding, innovation, and workforce development.

A committee member asked whether the SDC is partnering with additional counties beyond adjacent ones. Smith noted that while the spaceport is currently based in Williamson County and Burnet County chose not to participate, the SDC is actively working with other regional partners and envisions forming a broader cluster.

A committee member inquired about job training strategies. Smith responded that Firefly, a company involved with the initiative, is prioritizing middle-skill jobs. For soft and mid-tech roles, they plan to collaborate with local independent school districts (ISDs).

Additional questions from committee members addressed wage levels, potential testing sites, and opportunities within the spaceport's supply chain.

4. Overview of Economic Growth Business Incubator's (EGBI) Services & Impact

Larissa Davila, Executive Director of Economic Growth Business Incubator (EGBI), provided an overview of EGBI, a nonprofit business incubator founded in 2003 that supports small business development across Central Texas. EGBI offers training, coaching, and resources to help aspiring and existing entrepreneurs—especially those facing barriers to growth. The organization serves clients in several CAPCOG counties, including Bastrop, Blanco, Burnet, Caldwell, Hays, Travis, and Williamson. A committee member asked about the cost of services. Davila explained that coaching is provided free of charge, while workshops and training sessions carry a small fee.

A committee member inquired about how EGBI promotes its services. Davila noted they use a combination of a mailing list, referral partners, word of mouth, and social media to reach potential clients.

Committee members discussed the possibility of expanding services through additional partnerships. Davila shared that EGBI is actively working on building new partnerships to extend its reach and offerings.

Additionally, Davila reported that EGBI was named the #1 business incubator in Central Texas in 2023, 2024, and 2025, and also received Austin Community College's Lifelong Learning Award at the Learning Festival.

5. Updates from the Economic Development Administration (EDA)

Updates from Economic Development Administration (EDA) were cancelled by EDA.

6. Presentation of the 2025-2030 Comprehensive Economic Development Strategy (CEDS)

Kaileen McHugh, Planning and Economic Development Coordinator, CAPCOG presented on the 2025-2030 Comprehensive Economic Development Strategy (CEDS).

Mr. Bill Hamilton requested clarification on the forecast data being used. Ms. McHugh stated the forecast data would cover the years from 2025-2030.

Commissioner Ann Howard wanted to know if the strategy plan process worked out as expected. Ms. McHugh provided the positives and negatives of the strategy plan process. Charles Simon added there was participation from all 10 counties in the CAPCOG region and good feedback was provided from those who attended and participated in those areas.

Council Member Kevin Harris wanted to know what happens with the information as there are changes in elected officials and, more specifically, which staff receive this information. Charles Simon provided insight into how this information is dispersed and discussed CAPCOG's goals to be in contact with each county's key staff. Mr. Tracy also added the importance of being more deliberate in sharing information and ensuring each county officials and staff are up to date on information.

Council Member Ortega, Vice Chair, wanted to know if there is a way to determine whether key county staff are receiving this information. Mr. Simon explained the information was provided in various ways to each of the key staff members. Mr. Tracy, Chair, suggested some of the information could be used as key points of discussion in EDAC agenda items. Commissioner Howard added this should be included in the CAPCOG General Assembly to target key personnel in Economic Development. Mr. Simon stated this can be investigated and added to the general assembly topics.

7. Roundtable Discussion

Kaileen McHugh provided updates on census data for areas with populations over 20,000 for the CAPCOG region as of May 15, 2025.

Judge Hoppy Haden began the discussion related to 2 Texas legislative bills and their effects on bond elections.

8. Other Business

No other business was presented for discussion.

Michael Shear, CEO of Strategic Office Networks and Advisor to the Autonomy Institute, will present on Distributed Work Centers. These centers house multiple employers in dedicated office suites, tailored to local hiring needs, and are securely connected via private broadband, ensuring high-capacity, low-latency communication. This distributed model not only alleviates traffic congestion and creates local job opportunities but also supports advanced technologies such as virtual presence, holographic telepresence, and augmented reality. Additionally, centers have the potential to offer remote education, healthcare services, community events, and emergency response capabilities. Operating through a public-private partnership, the model integrates real estate and ICT infrastructure to meet the needs of a knowledge-based workforce, boosting productivity, quality of life, and sustainable economic growth.

RE: Item 7 – Texas State Technical College (TSTC) - Connecting with Industry

Christi Scow, EDAC member and Industry Relations Specialist at Texas State Technical College (TSTC), will share an overview of TSTC's programs in the region. TSTC serves Central Texas through the East Williamson County Higher Education Center (EWCHEC), offering educational opportunities and workforce readiness programs in Hutto and Taylor. In collaboration with Temple College and Texas A&M University-Central Texas, TSTC provides certificates, as well as associate, bachelor's, and master's degrees. Additionally, TSTC recently broke ground on a 70,635-square-foot Advanced Manufacturing Center of Excellence, scheduled to open in spring 2027, with programs in Advanced Manufacturing Technology-Semiconductor, Industrial Maintenance, and Precision Machining Technology.
